SB-04F-1836

1		SB-04F-1836: Title VI – Expiration of Appointment Applications
3	Whereas:	The Student Government of the University of North Florida was established to represent student concerns in all University wide matters;
4 5 6 7	Whereas:	The Student Senate is the legislative body of the University of North Florida's Student Government given the responsibility of carrying out such legislative acts that are necessary and proper for the Student Body of the University of North Florida;
8 9	Whereas:	Legislation dealing with necessary and proper statutory revisions shall be considered by Student Senate;
10 11	Whereas:	The Election Statutes are in need of revision and it is the Student Senate's responsibility to make our statutes proper for the needs of our students;
13 14	Whereas:	The current window for election dates allow only a two week deviation in the election dates and do not take into consideration conflicts with University scheduling such as holidays and Spring Break;
15 16 17	Whereas;	The following addition would result in the voiding of an appointment application if the appointee has not met the necessary requirements of becoming a senator within ninety (90) days of submitting their application;
18	Whereas:	The following changes will be made to Title VI:
19 20 21		608.3 C. 3. If an appointee has not attended and/or been reviewed by ESAC within ninety (90) days of submitting their application, the appointment application is then voided.
22 23 24	Therefore:	Let it be enacted, by the University of North Florida Student Government that the proposed revisions are made into Title VI of the Student Government Statutes.
