## SB-04F-1842

1 *SB-04F-1842 : 3<sup>rd</sup> Annual CCEC Symposium*

2 Whereas: The Student Government of the University of North Florida was established to represent  
3 student concerns in all University wide matters, and;

4 Whereas: The Budget and Allocations Committee is a standing committee of the Student Government  
5 Senate, responsible for funding only those entities that comply with the Student Government  
6 mission which is to represent student concerns in all university wide matters while  
7 developing and promoting programs and activities of practical value and interest to students,  
8 and;

9 Whereas: This purchase or activity reflects the genuine student interest and enhances the educational,  
10 social, cultural, and recreational interests of the University of North Florida students and;

11 Whereas: The College of Computing, Engineering, & Construction is requesting funds to  
12 host it's third annual student organized Symposium and Career Showcase;  
13 scheduled for Wednesday, April 13, 2005 in the Robinson Student Center. The  
14 event is targeted at persons interested in Information Technology, Computing  
15 Sciences, Engineering, and Building Construction Management in government,  
16 industry, and academia.;

17 Whereas: The requested funds will be divided between the following:

18	Food	\$1,764.00
19	Misc. Expenses	\$1,250.00
20	<b>Total:</b>	<b>\$3,014.00</b>

21 **Therefore: Let it be enacted, by the University of North Florida Student Government,**  
22 **that \$3,014.00 from the Special Request Index 402097 be used to pay for the**  
23 **3<sup>rd</sup> Annual CCEC Symposium.**
