SB-04F-1844 : Title XI Chapter Updates

2 Whereas: The Student Government of the University of North Florida was established to represent
3 student concerns in all University wide matters, and;

4 Whereas: The Student Senate is the legislative body of the University of North Florida's Student
5 Government given the responsibility of carrying out such legislative acts that are
6 necessary and proper for the Student Body of the University of North Florida;

7 Whereas: Legislation dealing with necessary and proper statutory revisions shall be considered by
8 Student Senate;

9 Whereas: The Constitution and Statutes Committee is responsible for making revisions to the
10 Student Government Constitution and Statutes as needed, and;

11 Whereas: Title XI is in need of revision;

12 Whereas: The Chapters within Title XI: The Executive Agency Statute have changed and the
13 legislation within needs to be updated to be in accordance with the proper Chapters;

14 **Therefore: Let it be enacted, that the following changes be made to Title IX:**

15 **Line 1100.4.D.1 read as follows:**

16 The Director may act within the provisions stated in Chapter 1100.4 A to
17 achieve maximum execution of the statutory responsibilities of the Agency.

19 **Chapter 1100.7 The Agencies read as follows:**
