SB-04F-1845

SB-04F-1845 Senate Sponsorship

2 Whereas: The Student Government of the University of North Florida was established to represent
 3 student concerns in all University wide matters, and;

4 Whereas: The Budget and Allocations Committee is a standing committee of the Student Government
 5 Senate, responsible for funding only those entities that comply with the Student Government
 6 mission which is to represent student concerns in all university wide matters while
 7 developing and promoting programs and activities of practical value and interest to students,
 8 and;

9 Whereas: As the Budget and Allocations Committee, it is our responsibility to review and revise the
 10 Finance Code (Title VIII) when necessary;

11 Whereas: The Finance Code controls the funds that are budgeted each year by the B&A Committee and
 12 is the governing statute of all money used through Student Government;

13 Whereas: The Finance Code is in need of minor revisions, corrections, and additions for today's needs
 14 by the students;

15 **Therefore: Let it be enacted, the following line in Title VIII- The Finance Code read as**
 16 **follows:**

17 840.5 In order for the B&A Committee to hear a request, the RSO must be
 18 sponsored by a member of the Student Senate. The SG Treasurer shall assist
 19 the student organization in finding a Senate Sponsor. If the RSO cannot find
 20 a Senate Sponsor, they shall be sponsored by the Senate President Pro-
 21 Tempore. It shall be the Senate Sponsor's duty to write the bill that shall be
 22 presented to Senate upon approval of the B&A Committee.
