1	SB-04F-1847 : Paper Ballot Override	
2	Whereas:	The Student Government of the University of North Florida was established to represent student concerns in all University wide matters, and;
4 5 6 7	Whereas:	The Student Senate is the legislative body of the University of North Florida's Student Government given the responsibility of carrying out such legislative acts that are necessary and proper for the Student Body of the University of North Florida;
8 9	Whereas:	Legislation dealing with necessary and proper statutory revisions shall be considered by Student Senate;
10 11	Whereas:	The Constitution and Statutes Committee is responsible for making revisions to the Student Government Constitution and Statutes as needed, and;
	Whereas:	Title IV is in need of revision;
13 14	Whereas:	Paper Balloting is not always necessary for appointments to the Executive Branch or the Student Senate;
15 16	Whereas:	The Student Senate needs the ability to override the paper balloting in favor of a roll call vote;
17	Therefore:	Let it be enacted, that the following changes be made to Title IV:
18 Line 400.1.K. be inserted and read as follows:		
19 20 21		The Legislative Branch shall be able to override Paper Balloting for all appointments in favor of a roll call vote by a two-thirds $(2/3)$ vote.
