SB-04F-1849

1		SB-04F-1849: Title VII Chapter Updates
2 3	Whereas:	The Student Government of the University of North Florida was established to represent student concerns in all University wide matters, and;
4 5 6 7	Whereas:	The Student Senate is the legislative body of the University of North Florida's Student Government given the responsibility of carrying out such legislative acts that are necessary and proper for the Student Body of the University of North Florida;
8 9	Whereas:	Legislation dealing with necessary and proper statutory revisions shall be considered by Student Senate;
10 11	Whereas:	The Constitution and Statutes Committee is responsible for making revisions to the Student Government Constitution and Statutes as needed, and;
12	Whereas:	Title VII is in need of revision;
3 14	Whereas:	The Chapters in Title VII have changed and the legislation within needs to be updated to be in accordance with the proper Chapters;
15	Therefore:	Let it be enacted, that the following changes be made to Title VII:
16		Line 715.3 read as follows:
17 18 19		The initiation procedures stated in Chapter <u>711.1</u> are superceded by the provisions set down in this chapter.
20		Line 715.4 read as follows:
21 22 23		The Senate President is charged with the obligatory duty of enforcing this chapter, in accordance with Title VII (with the exception of the aforementioned chapter <u>711.1</u>)."
