# SENATE LEGISLATION

## SB-04F-1852

1 **SB-04F-1852 : Student Physical Therapy Club Travel**

2 Whereas: The Student Government of the University of North Florida was established to represent  
3 student concerns in all University wide matters, and;

4 Whereas: The Budget and Allocations Committee is a standing committee of the Student Government  
5 Senate, responsible for funding only those entities that comply with the Student Government  
6 mission which is to represent student concerns in all university wide matters while  
7 developing and promoting programs and activities of practical value and interest to students,  
8 and;

9 Whereas: This purchase or activity reflects the genuine student interest and enhances the educational,  
10 social, cultural, and recreational interests of the University of North Florida students and;

11 Whereas: The Student Physical Therapy Club wishes to travel to The American Physical  
12 Therapy Association Conference in New Orleans from February 24<sup>th</sup> to February  
13 27<sup>th</sup>, for the purpose of interacting with professionals in the field. The knowledge  
14 and networking involved would be highly supplementary to the college of health  
15 and all students and professors within the college of health.

16 Lodging: \$1,350.00 Gas: \$1,000.00

17 **Total:**

18 **Therefore: Let it be enacted, by the University of North Florida Student Government,**  
19 **that \$2,350.00 from the Travel Request Index 402028 be used to pay for**  
20 **Travel for the Student Physical Therapy Club.**
