# SENATE LEGISLATION

## SB-05S-1851

1 *SB-05S-1851 : ESAC Chairman's Responsibility to Recognize Appointees*

2 Whereas: The Student Government of the University of North Florida was established to  
3 represent student concerns in all University wide matters;

4 Whereas: The Student Senate is the legislative body of the University of North Florida's  
5 Student Government given the responsibility of carrying out such legislative acts  
6 that are necessary and proper for the Student Body of the University of North  
7 Florida;

8 Whereas: Legislation dealing with necessary and proper statutory revisions shall be  
9 considered by Student Senate;

10 Whereas: The Elections Statutes is in need of revision;

11 Whereas: Title VI does not currently require the ESAC Chairman to recognize students  
seeking appointment. The following revision would include this responsibility;

13 Whereas; The following changes will be made to Title VI;

14 **601.1 P.** To recognize students seeking appointment to vacant senate  
15 seats, who have fulfilled the necessary requirements as  
16 outlined in chapter 608.1 and 608.2, on the Agenda of the  
17 next ESAC meeting.

18 **Therefore: Let it be enacted, by the University of North Florida Student Government**  
19 **that the proposed revisions are made into Title VI of the Student**  
20 **Government Statutes.**
