CONSTITUTIONAL AMENDMENT

CA-05S-1854

1 **CA-05S-1854: Travel Outside of Duval County**

2 Whereas: The Student Government of the University of North Florida was established to represent
3 student concerns in all University wide matters, and;

4 Whereas: The Student Senate is the legislative body of the University of North Florida's Student
5 Government given the responsibility of carrying out such legislative acts that are necessary
6 and proper for the Student Body of the University of North Florida;

7 Whereas: The Constitution and Statutes Committee is responsible for making revisions to the Student
8 Government Constitution and Statutes as needed, and;

9 Whereas: The University of North Florida's Student Government Constitution is in need of revision;

10 Whereas: Many Student Body Presidents have lived in the Jacksonville area, but outside of Duval
11 County;

12 Whereas: Florida Student Association travel outside of Duval County is part of the expected job duties
13 of a Student Body President;

14 Whereas: There is no comparable law in local, state, or federal books;

15 Whereas: The Student Body President leaving the county is not an "extreme circumstance" worthy of a
16 transition of power;

17 **Therefore: Let it be enacted that a Constitutional Referendum be placed on the 2005 Spring
18 Elections by the Elections, Selections, and Appointments Chair, and;**

19 **Further: Let it be further enacted that the referendum to be placed before the student body be
20 submitted as follows:**

21 **Article III. Section 6. Subsection A. be instituted and read as follows:**

22 The Vice President shall assume the duties of the President only in
23 extreme circumstances, such as physical incapacitation ~~or travel~~
24 ~~outside of Duval County~~, which makes it impossible to discharge the
25 duties of the office.
