2 3	Whereas:	The Student Government of the University of North Florida was established to represent student concerns in all University wide matters, and;	
4 5 6 7 8	Whereas:	The Budget and Allocations Committee is a standing committee of the Student Government Senate, responsible for funding only those entities that comply with he Student Government mission which is to represent student concerns in all university wide matters while developing and promoting programs and activities of practical value and interest to students, and;	
9 10 11	Whereas:	This purchase or activity reflects the genuine student interest and enhances the educational, social, cultural, and recreational interests of the University of North Florida students, and;	
.2 13	Whereas:	The Mock Trial club aides in the execution of this mission and has on numerous occasions presented UNF in a positive way to other universities, and;	
14	Whereas:	The cost broken-down for regional and nationals is as follows;	
15		Regional's Tallahassee: Lodging \$414	3.00, Transportation \$505.62,
16		Nationals Des Moines: Lodging \$219.	00, Transportation \$3,035.20,
17 18	Whereas:	The Mock Trial usually attends a Regional and National competition, Regional costing \$919.62 and National costing \$3,538.04;	
19 20 21	Therefore: Let it be enacted, by the University of North Florida Student Government, that \$4,458.00 from Travel Account 907027000 be used to fund the Mock Trial Team's two competition travel requests.		
Furthermore: If the Mock Trial team does not qualify to the National competition \$3,538.04 would be transferred back to Student Government travel account for reallocation.
