SB-05S-1860

SB-05S-1860: Weightlifting Club Travel

2 Whereas: The Student Government of the University of North Florida was established to
3 represent student concerns in all University wide matters, and;

4 Whereas: The Budget and Allocations Committee is a standing committee of the Student
5 Government Senate, responsible for funding only those entities that comply with
6 the Student Government mission which is to represent student concerns in all
7 university wide matters while developing and promoting programs and activities
8 of practical value and interest to students, and;

9 Whereas: This purchase or activity reflects the genuine student interest and enhances the
10 educational, social, cultural, and recreational interests of the University of North
11 Florida students, and;

12 Whereas: The Weightlifting Club of the University of North Florida wishes to travel to
13 Charleston Illinois from February 14, 2005, for the purpose of representing UNF
14 and competing in the 2005 Collegiate National Championships. The Weightlifting
15 Club hopes to broaden the scope of UNF's weightlifting experience while
16 competing for national recognition. The following prices compose the expenses.

17 Whereas: Registration- \$265.00; Lodging- \$230.00; Mini-Van- \$168.00; Airfare- \$1,252.00
18 **Total: \$1,915.00**

19 **Therefore: Let it be enacted, by the University of North Florida Student Government,**
20 **that \$1,915.00 from the Conference Travel Account 402028 be used to pay**
21 **for Weightlifting Club Travel.**
