# CONSTITUTIONAL AMENDMENT

## CA-05S-1867

*CA-05S-1867: Election Bylaw Changes Requiring Simple Majorities*

2 Whereas: The Student Government of the University of North Florida was established to  
3 represent student concerns in all University wide matters, and;

4 Whereas: The Student Senate is the legislative body of the University of North Florida's  
5 Student Government given the responsibility of carrying out such legislative acts  
6 that are necessary and proper for the Student Body of the University of North  
7 Florida;

8 Whereas: The Constitution and Statutes Committee is responsible for making revisions to  
9 the Student Government Constitution and Statutes as needed, and;

10 Whereas: The University of North Florida's Student Government Constitution is in need of  
11 revision;

12 Whereas: Voting procedures for Title VI are an aberration to the current norms;

13 Whereas: It should take a simple majority to change election statutes;

14 **Therefore: Let it be enacted that a Constitutional Referendum be placed on the 2005**  
15 **Spring Elections by the Elections, Selections, and Appointments Chair, and;**

16 **Further: Let it be further enacted that the referendum to be placed before the student**  
17 **body be submitted as follows:**

18 **Article II. Section 10. Subsection A. be instituted and read as follows:**

19 Enact under the procedures outlined in Section 7 of this Article,  
20 constitutional bylaws to be known as Student Government Statutes,  
21 with the exception of bylaws concerning elections, which shall  
22 require a two-thirds (2/3) vote of the Senate.
