SB-05S-1868AA: Title V Revisions

7 Whereas: The Student Government of the University of North Florida was established to represent
8 student concerns in all University wide matters, and;

9 Whereas: The Student Senate is the legislative body of the University of North Florida's Student
10 Government given the responsibility of carrying out such legislative acts that are
11 necessary and proper for the Student Body of the University of North Florida;

12 Whereas: Legislation dealing with necessary and proper statutory revisions shall be considered by
13 the Student Senate;

14 Whereas: Title V, the Judiciary, requires changes, because the current statutes do not afford the
15 Student Senate an adequate opportunity to interview appointments to the Judiciary, and;

16 Whereas: The following changes will be made Title V:

Chapter 507 Appointment to the Judiciary

18 To be appointed, the following actions must occur:

21 507.1 Any individual interested in joining the Judiciary must fill out an application form and
22 submit it to the Chief Justice, and the application will be forwarded to the Student
23 Government President.

25 507.2 In the event of a vacancy on the Judiciary, the Student Government President shall
26 appoint a nominee, from the Judiciary applications to fill the vacancy, and shall forward
27 the name to the Senate President 72 hours before the senate meeting.

29 507.3 The nominee must then appear before a Senate meeting to present him or herself during
30 "Judicial Appointments."

31
32 507.4 The nominee shall then appear before the Senate to present him or herself for questioning
33 by the Senate, the Senate must recognize the appearance of the judicial nominee.

35 507.6 The nominee shall present him or herself at the next Senate meeting, to receive majority
36 approval of the Student Senate, by paper balloting, with the seat number of the voting
37 senator in the corner. If appointed, the new justice shall be installed as outlined in
38 Chapter 903 of these Statutes.

40 507.7 Once installed as a member of the Student Government Judiciary, the term of the
41 appointed shall last until their resignation from the Judiciary, or concurrently, the length
42 of their tenure at the University of North Florida, up to six years maximum.

44 Therefore: Let it be enacted, by the University of North Florida Student Government that the proposed
45 revisions are made to Title V of the Student Government Statutes.
