SR-05S-1872: Student's Rights

2 Whereas: The Student Government of the University of North Florida was established to represent
3 student concerns in all University wide matters, and;

4 Whereas: In representing students concerns, Student Government as a whole believes that this
5 concern should be addressed;

6 Whereas: The University of North Florida is an institution that should provide students with an
7 academic environment that promotes academic excellence;

8 Whereas: All students have the right to be provided with an academic environment that is
9 reasonable and just;

10 Whereas: It is unjust and against students' rights for any professor(s) and instructor(s) to hinder
11 students from receiving an environment that promotes academic excellence;

12 Whereas: These rights include the allowance of making up all work including but not limited to
13 exams, quizzes, tests and papers if the absence of class is reasonable;

14 Whereas: Reasonable being with written proof of hospitalization, sickness, death and /or
15 emergencies;

16 Whereas: Any professor(s), instructor(s) that prohibit students from making up work missed
17 including but not limited to quizzes, test, exams, papers and are in violation of students
18 rights';

19 Whereas: These rights should be added to the Student Attendance Policy;

20 **Therefore: The University Student Senate resolves that the Faculty Association, The Office of**
21 **The Provost, Academic Affairs and Each College's Dean's office make these**
22 **suggestions a part of the UNF Attendance Policy for Students.**

23 **Furthermore: Let this resolution be forwarded to the Vice President of Academic Affairs, Dean of**
24 **College of Arts and Sciences, Dean of Coggin College of Business, Dean of College of**
25 **Computing, Dean Engineering and Construction, Dean College of Education and**
26 **Human Resources, Dean of College of Health, Faculty Association, and the**
27 **University President.**
