# SENATE LEGISLATION

### SB-05S-1880

1		SB-05S-1880: Student Life Transfer
2	Whereas:	The Student Government of the University of North Florida was established to represent student concerns in all University wide matters, and;
4 5 6 7 8	Whereas:	The Budget and Allocations Committee is a standing committee of the Student Government Senate, responsible for funding only those entities that comply with the Student Government mission which is to represent student concerns in all university wide matters while developing and promoting programs and activities of practical value and interest to students, and;
9 10 11	Whereas:	This purchase or activity reflects the genuine student interest and enhances the educational, social, cultural, and recreational interests of the University of North Florida students, and;
12 13 14 15 16 17	Whereas:	Due to a recent event regarding the purchase if insurance by Student Life, it has been brought to the attention of the UNF Student Senate and Budget and Allocations Committee that an allocated \$8,000.00 in the Student Life Budget, could be more effectively and efficiently used in reimbursing the Executive Branch for prior purchases and the funding of OPS Positions. The Transfer goes as follows:
18		\$6,000.00 from the Insurance line to OPS
19		\$2,000.00 from the Insurance line to the SG Executive account
20 21 22	Therefore:	Let it be enacted, by the University of North Florida Student Government, that \$8,000.00 from the Insurance line of Student Life Account 1402800 be transferred in the manner detailed above.
