SB-04F-1882

SB-05S-1882 : Individual Travel Request for Christopher Cox

2 Whereas: The Student Government of the University of North Florida was established to represent
3 student concerns in all University wide matters, and;

4 Whereas: The Budget and Allocations Committee is a standing committee of the Student Government
5 Senate, responsible for funding only those entities that comply with the Student Government
6 mission which is to represent student concerns in all university wide matters while
7 developing and promoting programs and activities of practical value and interest to students,
8 and;

9 Whereas: This purchase or activity reflects the genuine student interest and enhances the educational,
10 social, cultural, and recreational interests of the University of North Florida students and;

11 Whereas: Christopher Cox has been invited to attend the Western Political Science
12 Association Annual Meeting; to be held March 18, 2005, in Oakland California.
13 Attendance at this conference will represent the university in a positive light, at a
14 reputable organization within the field of Political Science.;

15 Whereas: The funds requested will be divided among the following:

16	Registration Fee	\$55.00
17	Lodging	\$184.80
18	Airline Tickets	\$232.00
19	Shuttle to/from Airport	\$28.00

20 **Total:** \$500.00

21 **Therefore:** Let it be enacted, by the University of North Florida Student Government, 009 104:23
22 that \$500.00 from the Special Request Index 402097 be used to pay for
23 Christopher Cox's attendance at the WPSA.
