1		SB-05S-1884: Dottie Dorian Fitness Center Equipment Request
2	Whereas:	The Student Government of the University of North Florida was established to represent student concerns in all University wide matters, and;
4 5 6 7 8	Whereas:	The Budget and Allocations Committee is a standing committee of the Student Government Senate, responsible for funding only those entities that comply with the Student Government mission which is to represent student concerns in all university wide matters while developing and promoting programs and activities of practical value and interest to students, and;
9 10	Whereas:	The Dottie Dorian Fitness Center exists to serve the needs of the student body by providing fitness and exercise facilities to students free of charge and;
11 12	Whereas:	In order to effectively serve the student body, the Fitness Center must maintain a wide-variety of exercise equipment in suitable and safe working order;
14	Whereas:	The Dottie Dorian Fitness Center currently contains several treadmills being utilized well beyond their intended lifespan;
15 16	Whereas:	<u>Four</u> Woodway Desmo Treadmills = \$31,180.34 <u>One</u> Nautilus F2FT Freedom Trainer = \$3,455.95
17		Total: \$34,647
18 19 20 21	Therefore:	Let it be enacted, by the University of North Florida Student Government, that \$34,647.00 be transferred from the Fund Balance Account (Index 890300) to Special Projects (Index 402081) to be used to pay for the purchase of <u>four</u> Woodway Desmo Treadmills and <u>one</u> Nautilus Freedom Trainer.
