SENATE LEGISLATION

SB-05S-1884

1 ***SB-05S-1884 : Dottie Dorian Fitness Center Equipment Request***

2 Whereas: The Student Government of the University of North Florida was established to represent
3 student concerns in all University wide matters, and;

4 Whereas: The Budget and Allocations Committee is a standing committee of the Student Government
5 Senate, responsible for funding only those entities that comply with the Student Government
6 mission which is to represent student concerns in all university wide matters while
7 developing and promoting programs and activities of practical value and interest to students,
8 and;

9 Whereas: The Dottie Dorian Fitness Center exists to serve the needs of the student body by providing
10 fitness and exercise facilities to students free of charge and;

11 Whereas: In order to effectively serve the student body, the Fitness Center must maintain a wide-
12 variety of exercise equipment in suitable and safe working order;

13 Whereas: The Dottie Dorian Fitness Center currently contains several treadmills being utilized well
14 beyond their intended lifespan;

15 Whereas: Four Woodway Desmo Treadmills = \$31,180.34
16 One Nautilus F2FT Freedom Trainer = \$3,455.95

17 **Total: \$34,647**

18 **Therefore: Let it be enacted, by the University of North Florida Student Government,**
19 **that \$34,647.00 be transferred from the Fund Balance Account (Index**
20 **890300) to Special Projects (Index 402081) to be used to pay for the purchase**
21 **of four Woodway Desmo Treadmills and one Nautilus Freedom Trainer.**
