# SENATE LEGISLATION

## SB-05S-1891

### *SB-05S-1891: National Society of Black Engineers (NSBE) Travel*

1

2 Whereas: The Student Government of the University of North Florida was established to  
3 represent student concerns in all University wide matters, and;

4 Whereas: The Budget and Allocations Committee is a standing committee of the Student  
5 Government Senate, responsible for funding only those entities that comply with  
6 the Student Government mission which is to represent student concerns in all  
7 university wide matters while developing and promoting programs and activities  
8 of practical value and interest to students, and;

9 Whereas: This purchase or activity reflects the genuine student interest and enhances the  
10 educational, social, cultural, and recreational interests of the University of North  
11 Florida students, and;

12 Whereas: The National Society of Black Engineers is a valuable student organization at the  
13 University of North Florida, steadfast in their mission to increasing the number of  
14 culturally responsible minority engineers who excel academically, succeed  
15 professionally, and positively impact the community, and;

16 Whereas: The NSBE Annual National Convention, taking place at the Hynes Convention  
17 Center, Boston, MA, on the twenty third day to the twenty seventh day of March  
18 in the Year of our Lord two thousand five, is a distinctive and worthwhile  
19 opportunity for the NSBE attendees to represent this University, and;

20 Whereas: Through the participation of NSBE at this convention, the University of  
21 North Florida Community will be enhanced by a variety of benefits and  
22 services, and;

23 Whereas: The following costs represent what is asked of senate;

24 Registration: \$760.00 Lodging: \$249.94 Transportation: \$1,140.00

25 Total: \$2,150.00 (\$2,149.64)

26 **Therefore: Let it be enacted, by the University of North Florida Student Government,**  
27 **that \$2,150.00 from the Conference Travel Index 402028 be used to pay for**  
28 **the above outlined costs regarding travel for the National Society of Black**  
29 **Engineers.**
