# SENATE LEGISLATION

## SB-05S-1892

1 *SB-05S-1892: College Republican State Convention Special Request*

2 Whereas: The Student Government of the University of North Florida was established to represent student  
3 concerns in all University wide matters, and;

4 Whereas: The Budget and Allocations Committee is a standing committee of the Student Government  
5 Senate, responsible for funding only those entities that comply with the Student Government  
6 mission which is to represent student concerns in all university wide matters while developing and  
7 promoting programs and activities of practical value and interest to students, and;

8 Whereas: This purchase or activity reflects the genuine student interest and enhances the educational, social,  
9 cultural, and recreational interests of the University of North Florida students, and;

10 Whereas: The College Republican Club is a valuable student organization at the University of North Florida,  
11 steadfast in its mission to increase the number of principled student citizens who understand the  
12 importance of excelling scholastically, succeeding professionally, and positively impacting the  
13 community around them, and;

14 Whereas: The CR State Convention, hosted here at the University of North Florida and managed by our CR  
15 Club leadership, on the eighth day to the ninth day of April in the Year of our Lord two  
16 thousand five, is a distinctive and worthwhile opportunity for all our students to partake  
17 in and it is a valuable chance for our student leaders to project and exercise the highest  
18 standards of excellence, creditability, and efficiency we so boldly work by and;

19 Whereas: Through the funds provided for this convention, the University of North Florida  
20 community will be enhanced by a variety of benefits and services, and;

21 Whereas: The following costs represent what is asked of senate;

22 Food: \$4,625.00                      Marketing: \$1,000.00                      Facility: \$375.00

23 Total: \$6,000.00

24 Therefore: Let it be enacted, by the University of North Florida Student Government, that \$6,000.00  
25 from the Special Request Index 402097 be transferred to special projects index 402081 to  
26 pay for the above outlined costs regarding the special request of the College Republican  
27 State Convention.
