1		SB-05S-1893A: 2005-2006 Activity and Service Fee Fiscal Budget
2	Whereas:	The Student Government of the University of North Florida was established to represent student concerns in all University wide matters, and;
4 5 6 7 8	Whereas:	The Budget and Allocations Committee is a standing committee of the Student Government Senate, responsible for funding only those entities that comply with the Student Government mission which is to represent student concerns in all university wide matters while developing and promoting programs and activities of practical value and interest to students, and;
9 10	Whereas:	The 2005-2006 Balanced Budget, with provisionary language or riders, was placed on display in the SG office on February 28, 2005 at 8:00 am and;
	Whereas:	A Budget Workshop was completed on March 4, 2005 at 12:00 pm and;
12 13 14 15 16	Whereas:	Title VIII states in 822.2 "The B&A approved budget shall be posted within two business days of approval and shall be displayed in public view for a minimum of five business days prior to the Senate meeting in which it will be placed on the agenda. During this period, a campus-wide open forum will be conducted by the B&A Chairperson to explain the budget process and the B&A recommended budget," and;
17 18 19	Therefore:	Let it be enacted, by the University of North Florida Student Government, that the proposed attached 2005-2006 Balanced A&S Fee Fiscal Budget be accepted with provisionary language and riders.
