SENATE LEGISLATION

SB-05S-1902

1 ***SB-05S-1902 : Student Council for Exceptional Children Travel***

2 Whereas: The Student Government of the University of North Florida was established to represent
3 student concerns in all University wide matters, and;

4 Whereas: The Budget and Allocations Committee is a standing committee of the Student Government
5 Senate, responsible for funding only those entities that comply with the Student Government
6 mission which is to represent student concerns in all university wide matters while
7 developing and promoting programs and activities of practical value and interest to students,
8 and;

9 Whereas: This purchase or activity reflects the genuine student interest and enhances the educational,
10 social, cultural, and recreational interests of the University of North Florida students and;

11 Whereas: The Student Council for Exceptional Children is a Campus organization widely
12 known for its knowledge and experience regarding educational and interactive
13 techniques for special and gifted children. The SCEC wishes to travel to
14 Baltimore, MD from April 6, 2005 until April 10, 2005 for the purpose of
15 attending the 2005 CEC Convention and Exposition. The below listed costs
16 outline the funding sought to attend this trip.

17 Whereas: 5 airline tickets at \$178.40 each

18 **Total: \$893.00**

19 **Therefore: Let it be enacted, by the University of North Florida Student Government,**
20 **that \$893.00 from the Conference Travel Index 402028 be used to pay for the**
21 **above mentioned expenses.**
