### *SB-05S-1903 : Baptist Collegiate Ministries Travel*

- 2 Whereas: The Student Government of the University of North Florida was established to represent  
3 student concerns in all University wide matters, and;
- 4 Whereas: The Budget and Allocations Committee is a standing committee of the Student Government  
5 Senate, responsible for funding only those entities that comply with the Student Government  
6 mission which is to represent student concerns in all university wide matters while  
7 developing and promoting programs and activities of practical value and interest to students,  
8 and;
- 9 Whereas: This purchase or activity reflects the genuine student interest and enhances the educational,  
10 social, cultural, and recreational interests of the University of North Florida students and;
- 11 Whereas: Baptist Collegiate Ministries are a club representing and ministering to hundreds  
12 of Students of the Christian Faith. Besides working on campus to better students,  
13 BCM seeks the knowledge and council of other off-campus sources, so as to  
14 better the quality of learning and networking amongst its students at UNF. BCM  
15 seeks to send 3 students to Atlanta to attend a Leadership Forum from April 14,  
16 2005 until April 16, 2005. The below mentioned costs outline what has been  
17 requested in order to attend this Conference.
- 18 Whereas: Registration: 3 \* \$75 Lodging: 2 rooms\* \$43 \* 2 nights Trans: \$205.9

- 20 **Total: \$517.00**
- 21 **Therefore: Let it be enacted, by the University of North Florida Student Government,**  
22 **that \$517.00 from the Travel Index 402028 be used to pay for the above**  
23 **mentioned expenses.**
