## SB-05S-1906

### SB-05S-1906: Title III Changes

- 2   Whereas:    The Student Government of the University of North Florida was established to represent
- 3                    student concerns in all University wide matters, and;
- 4   Whereas:    The Student Senate is the legislative body of the University of North Florida's Student
- 5                    Government given the responsibility of carrying out such legislative acts that are
- 6                    necessary and proper for the Student Body of the University of North Florida;
- 7   Whereas:    Legislation dealing with necessary and proper statutory revisions shall be considered by
- 8                    Student Senate;
- 9   Whereas:    The Constitution and Statutes Committee is responsible for making revisions to the
- 10                  Student Government Constitution and Statutes as needed, and;
- 11   Whereas:    Title III is in need of revision;
- 12   Whereas:    The Peer Student Advocate's and the Student Lobbyist's duties are directly related to the
- 13                  functions of the Student Advocacy Committee of the Student Senate;
- 14   **Therefore:    Let it be enacted, that the following changes be made to Title III:**
- 15                  303.8.C.4    The Peer Student Advocate shall attend the meetings and report to
- 16                  the Student Advocacy Committee of the Student Senate.

- 18                  303.8.D.4    The Student Lobbyist shall attend the meetings and report to the
- 19                  Student Advocacy Committee of the Student Senate.
