1 *SB-05S-1910: Spring 2005 Elections Validation*

2 Whereas: The Student Government of the University of North Florida was established to represent
3 student concerns in all University wide matters;

4 Whereas: The Student Senate is the legislative body of the University of North Florida's Student
5 Government given the responsibility of carrying out such legislative acts that are
6 necessary and proper for the Student Body of the University of North Florida;

7 Whereas: The Spring 2005 General Election and Inter-Collegiate Elections, as provided for by the
8 Constitution were properly conducted;

9 Whereas: Title VI requires the results of each election be validated at the Senate meeting following
10 the elections;

11 Therefore: Let it be enacted that the Spring 2005 General Election and the Inter-Collegiate
12 Elections results be validated as written below:
