# SENATE LEGISLATION

## SB-05SB-1928

- 2   Whereas:     The Student Government of the University of North Florida was established to represent  
3                   student concerns in all University wide matters, and;
- 4   Whereas:     The Budget and Allocations Committee is a standing committee of the Student Government  
5                   Senate, responsible for funding only those entities that comply with the Student Government  
6                   mission which is to represent student concerns in all university wide matters while  
7                   developing and promoting programs and activities of practical value and interest to students,  
8                   and;
- 9   Whereas:     This purchase or activity reflects the genuine student interest and enhances the educational,  
10                  social, cultural, and recreational interests of the University of North Florida students and;
- 11   Whereas:     Osprey Productions is an extended entity of student government and for which it  
12                  represents student government in a positive manner;
- 13   Whereas:     Osprey Productions puts on programs that are of huge interest to the student body with  
14                  out failure on yearly bases. These programs never fail in having a huge number of the  
15                  student body in attendance;
- 16   Whereas:     Attending the NACA South Conference on September 29 thou October 2 in Chattanooga  
17                  Tennessee will provide Osprey Productions with the tools needed to have successful  
18                  events in the upcoming year. At the NACA South Conference Osprey Productions will  
19                  receive innovative ideas on how to promote events. At the same time they will be  
20                  introduced to a number of popular performers and receive the means to have them  
21                  perform at UNF;
- 22   Whereas:     Listed below are the broken down cost for lodging, travel and admission for four people;
- 23   Whereas:     Registration                 **\$1176.00**
- 24                   Lodging                                 **\$375.00**
- 25                   Transportation                         **\$1286.00**
- 26                   Other                                     **\$20.00**
- 27                   **Total:                                 \$2,167.00**
- 28   **Therefore:     Let it be enacted, by the University of North Florida Government, that \$2,167.00**  
29                   **from the Travel account 402028 be used to pay for the travel of Osprey Production**  
30                   **to Chattanooga Tennessee for the NACA South Conference.**
