SENATE LEGISLATION

SB-05SB-1929

- 2 Whereas: The Student Government of the University of North Florida was established to represent
 3 student concerns in all University wide matters, and;
- 4 Whereas: The Budget and Allocations Committee is a standing committee of the Student Government
 5 Senate, responsible for funding only those entities that comply with the Student Government
 6 mission which is to represent student concerns in all university wide matters while
 7 developing and promoting programs and activities of practical value and interest to students,
 8 and;
- 9 Whereas: This purchase or activity reflects the genuine student interest and enhances the educational,
 10 social, cultural, and recreational interests of the University of North Florida students and;
- 11 Whereas: In the incoming year Student Life will be going thou restructuring. After the
 12 restructuring is complete the Dean of Students will no longer be the Student
 13 Government advisor. This restructuring will now provide Student Government
 14 with an SG advisor for which its sole purpose is dealing with all SG matters. This
 15 position will report to the Dean of Students;
- 16 Whereas: This allocation from special request is a one time, non-recurring allocation for the
 17 salary including benefits of \$50,384;
- 18 Whereas: SG Advisor Position;
- 19 Annual Rate of pay \$38,881.77
- 20 Annual Increase \$1,166.45
- 21 Total Annual Benefits \$10,336.72
- 22 **Total: \$50,384**
- 23 **Therefore: Let it be enacted, by the University of North Florida Student**
 24 **Government, that \$50,384 from the Fund Balance Index 140000 be used**
 25 **to pay for the salary of an SG advisor.**

2 Whereas: The Student Government of the University of North Florida was established to represent student

4 Whereas: The Budget and Allocations Committee is a standing committee of the Student Government Senate,
5 responsible for funding only those entities that comply with the Student Government mission which is
6 to represent student concerns in all university wide matters while developing and promoting programs
7 and activities of practical value and interest to students, and;

8 Whereas: This purchase or activity reflects the genuine student interest and enhances the educational, social,
9 cultural, and recreational interests of the University of North Florida students and;

10 Whereas: In the upcoming Academic Year Student Life will be going through restructuring. After
11 the restructuring is complete, the Dean of Students will no longer be the Student
12 Government Advisor. This restructuring will now provide Student Government with an
13 SG Advisor for which its sole purpose is dealing with all SG matters. This position will
14 report to the Dean of Students and Assistant Vice President for Student Life;

15 Whereas: This allocation from Special Request is a one time, non-recurring allocation for the salary
16 including benefits of \$50,384;

17 Whereas: SG Advisor Position/ Associate Director

18 Annual Rate of pay \$38,881.77

19 Annual Increase \$1,166.45

20 Total Annual Benefits \$10,336.72

21 Total: \$50,384

22 Therefore: Let it be enacted, by the University of North Florida Student Government, that
23 \$50,384 from the Fund Balance Index 402097 to be transferred to Student Life
24 Index 402800 to pay for the salary of the SG Advisor/Associate Director
25 position.
