CA-05SB-1930: GPA Qualifications

2 Whereas: The Student Government of the University of North Florida was established to represent
3 student concerns in all University wide matters, and;

4 Whereas: The Student Senate is the legislative body of the University of North Florida's Student
5 Government given the responsibility of carrying out such legislative acts that are
6 necessary and proper for the Student Body of the University of North Florida;

7 Whereas: Legislation dealing with necessary and proper statutory revisions shall be considered by
8 Student Senate;

9 Whereas: The Constitution and Statutes Committee is responsible for making revisions to the
10 Student Government Constitution and Statutes as needed, and;

11 Whereas: The Constitution is in need of revision;

12 Whereas: The University of North Florida Student Government qualifications for service do not
 meet the active standards of other university organizations and clubs;

14 **Therefore:** **Let it be enacted, that a Constitutional Referendum be placed on the 2005 Fall**
15 **election by the Elections, Selections and Appointments Chair, and:**

16 **Further:** **Let it further be enacted, that the Referendum to be placed before the student body**
17 **be submitted as follows:**

18 **Article II, Section 2, Subsection C:** Every Senator must be an A&S fee paying student,
19 enrolled in at least one (1) class during both the fall and spring semester at the University of
20 North Florida, and maintaining a 2.25 GPA or higher. Senators may continue to serve
21 during the summer semester without being enrolled in a class as long as they are still
22 considered students by the University of North Florida.

24 **Article III, Section 2, Subsection B:** The President, Vice President, and all members of
25 the Executive Branch must be A&S fee paying students, enrolled in at least one (1) class
26 during both the fall and spring semester, and maintaining a 2.25 GPA or higher.

28 **Article IV, Section 3, Subsection B: Qualifications:** Justices must be A&S fee paying
29 students, enrolled in at least one (1) class during both the fall and spring semester, and
30 maintaining a 2.25 GPA or higher.
