## **SENATE LEGISLATION CA-05SB-1932**

1		CA-05SB-1932: Attorney General
2 3	Whereas:	The Student Government of the University of North Florida was established to represent student concerns in all University wide matters, and;
4 5 6	Whereas:	The Student Senate is the legislative body of the University of North Florida's Student Government given the responsibility of carrying out such legislative acts that are necessary and proper for the Student Body of the University of North Florida;
7 8	Whereas:	Legislation dealing with necessary and proper statutory revisions shall be considered by Student Senate;
9 10	Whereas:	The Constitution and Statutes Committee is responsible for making revisions to the Student Government Constitution and Statutes as needed, and;

13	Whereas:	The University of North Florida Student Government Attorney General should be a required position due to its necessity throughout the statutes;
