# SENATE LEGISLATION

## SB-05SB-1936

1 **SB-05SB-1936: Candidate Application Filing Date**

2 Whereas: The Student Government of the University of North Florida was established to  
3 represent student concerns in all University wide matters, and;

4 Whereas: The Student Senate is the legislative body of the University of North Florida's  
5 Student Government given the responsibility of carrying out such legislative acts  
6 that are necessary and proper for the Student Body of the University of North  
7 Florida;

8 Whereas: Legislation dealing with necessary and proper statutory revisions shall be  
9 considered by the Student Senate;

10 Whereas: Title VI is in need of revision

11 Whereas: The current Title VI being outdated should allow for the Elections Supervisor to  
12 choose a more appropriate date for the candidate application due date.

13 **Therefore: Let it be enacted, that the following changes be made to Title**  
14 **VI:**

15 **Chapter 604.2 Becoming a Candidate**

16 **B. Candidate Application**

17 3. The Candidate Application must be submitted by 5:00pm ~~seven (7)~~  
18 business days no earlier than the fifteenth (15) business day and no later than the  
19 fifth (5) business day before the first day of the election. Furthermore, the  
20 Candidate Application due date must not be before the Declaration of Intent due  
21 date.
