JR-05F-1945: Objecting Block Tuition

- 2 Whereas: The Student Government of the University of North Florida was
3 established to represent student concerns in all University wide matters;
- 4 Whereas: In representing student concerns, Student Government as a whole
5 believes that this concern should be addressed;
- 6 Whereas: The University of North Florida Student Government in representing the
7 Student Body, strongly disagrees with the proposed Florida Senate Bill
8 1798- Block Tuition
- 9 Whereas: Student Government believes that Block Tuition is not in the best interest
10 of the student body and the University as a whole;
- 11 Whereas: Student Government took it upon itself on behalf of the students of this
12 University to act in their best interests to openly reject the proposals of
13 block tuition and those given by the Board of Governors and;
- 14 **Therefore: May it be resolved, by the Student Government of the University of**
15 **North Florida, that we strongly reject block tuition in the Florida**
16 **University system.**
- 17 **Therefore: Student Government will do everything in its power to fight Block**
18 **Tuition at the University of North Florida and in the entire Florida**
19 **University System.**
- 20 **Furthermore: This resolution shall be sent to the President of the University of North**
21 **Florida, Board of Trustees, Provost, Faculty Association, The Governor,**
