## SENATE LEGISLATION SB-05F-1953-A

Travel 2 Whereas: The Student Government of the University of North Florida was established to represent 3 student concerns in all University wide matters, and; Whereas: The Budget and Allocations Committee is a standing committee of the Student Government 4 5 Senate, responsible for funding only those entities that comply with the Student Government 6 mission which is to represent student concerns in all university wide matters while 7 developing and promoting programs and activities of practical value and interest to students, 8 and; 9 This purchase or activity reflects the genuine student interest and enhances the educational, Whereas: 10 social, cultural, and recreational interests of the University of North Florida students and; 11 Whereas: The travel of the Student Physical Therapy Association to San Diego, California 2 for the Annual American Physical Therapy Association Conference from February 1, 2006 to February 5, 2006 would provide much needed information to 14 the students traveling and the students they interact with when returning to 15 campus; The following funds for the conference would serve the students of the SPTA and 16 Whereas: 17 the University of North Florida; 18 Lodging: \$1020.66 19 Transportation: \$3148.00 20 Total: \$4168.66 21 **Therefore:** Let it be enacted, by the University of North Florida Student Government, 22 that \$4168.66 from the Special Request Index 402097 be used to pay for the 23 Student Physical Therapy Association's travel to its annual conference.
