## SENATE LEGISLATION SB-05F-1959

1 SB-05F-1959 : Renaming of Fund Balance Index 2 Whereas: The Student Government of the University of North Florida was established to represent 3 student concerns in all University wide matters, and; Whereas: The Budget and Allocations Committee is a standing committee of the Student Government 4 Senate, responsible for funding only those entities that comply with the Student Government 5 6 mission which is to represent student concerns in all university wide matters while 7 developing and promoting programs and activities of practical value and interest to students, 8 and; 9 This purchase or activity reflects the genuine student interest and enhances the educational, Whereas: social, cultural, and recreational interests of the University of North Florida students and; 10 The State requires all unused funds are to be reallocated into the Budget and are 11 Whereas: ? required to be identified under a general Index title; 13 Whereas: The Fund Balance needs to be split up into Indexes containing a general Index title that identifies its use and has been recommended to be identified into the 14 following accounts and because of those changes Title VIII was also in need of 15 16 revision: \$1.2 Million 17 General Reserve Index 18 Scholarship Interest Earning Index \$600,000 19 801.8 Special Wage Increase Index - an account or fund established to 20 indicate a specific surplus necessary to meet contingent liabilities upon direction from the Student Senate. 21 22 801.13 General Reserve Index - an accumulation of money generated 23 through excess tuition hours and unexpended budget allocations. 801.14 Scholarship Interest Earning Index - interest earning account to 24 provide funds for annually awarded Student Government scholarships. 25 Chapter 842 General Reserve Policies and Process 26 (The term Fund Balance used in Chapter 842 and any place in Title VIII will be replaced with the new term General Reserve) 28
