2 3	Whereas:	The Student Government of the University of North Florida was established to represent student concerns in all University wide matters, and;

	Whereas:	The Candidate Application needs to include a Declaration of Intent from the Candidate;
12 13	Whereas:	This statement will allow the Student Government Advisor to check the validity of the candidate i.e. GPA Requirement, Academic Standing, and College Seat (if applicable);
14 15	Therefore:	Let it be enacted, by the University of North Florida Student Government that the following changes be made to Title VI;

A statement of understanding, signed by the candidate ensuring (s)he has read and understands the guidelines and consequences expressed within the Election Code, and pledges to adhere to the guidelines set forth in the Student Government Constitution, Statutes, Election Code, and all other applicable university policies.
22 23 24 25 26 27 28		A. 1. A Declaration of Intent form shall be signed and turned into the Elections Supervisor by 5:00 pm twenty (20) business days before the start of the election. The form shall be signed by the candidate ensuring (s)he has read and <u>understood</u> the guidelines and consequences expressed within the Election Code, and pledges to adhere to the guidelines set forth in the Student Government Constitution, Statutes, Election Code, and all other applicable university policies.
