SB-10F-2434: Title XII Updates

- 2 Whereas: The Student Government of the University of North Florida was established to represent
3 student concerns in all University wide matters, and;
- 4 Whereas: Student Government is responsible for revising and updating the bylaws from time to time
5 and;
- 6 Whereas: The Senate is the appropriate body charged with approve such revisions, and;

- 8 Whereas: Legislation dealing with necessary and proper statutory revisions shall be considered by
9 Student Senate;

- 11 Whereas: Title XII is currently incomplete and in need of minor revisions;

- 14 Whereas: The following changes will be made to Title XII
- 15
- 16 1200.1 The Student Advocacy Committee is one of the four standing committees of
17 the Student Government Senate. The Student Advocacy Committee is
18 responsible for acting as a liaison between the University of North Florida's
19 student body and the Student Government, and promotes those programs and
20 activities, locally or nationally, which are in the interests of the University of
21 North Florida.
- 22
- 23 1200.2 The Student Advocacy Committee shall be composed of up to eleven SG
24 Senators including the Chairman and ten SG Senators. All voting members of
25 the committee will be elected or appointed senators including the Vice
26 Chairperson. Non-voting Ex-Officio members shall include Constitutions
27 and Statutes (CSC) Chairperson, Budget and Allocations (B&A) Chairperson,
28 Elections, Selections, and Appointments Committee (ESAC) Chairperson,
29 Senate President, Senate Pro-Tempore and Faculty Association
30 Representative; SG Advisor.

- 32 ~~1200.3 All special requests for SAC sanctioned events are required to go through first~~
33 ~~reading in the Student Advocacy Committee.~~

- 6 1200.3 The Student Advocacy Committee shall follow Robert's Rules of Order.
- 7
- 8 1200.4 The Student Advocacy Committee shall have jurisdiction over Title XII.

- 10 1200.5 Amendments to Title XII are subject to the normal legislative process.
- 11
- 12 1200.6 The Student Advocacy Committee is responsible for panning four events
13 during each fall and spring semester that promotes school spirit and/or unity among
14 students.
- 15
- 16 1200.7 The Student Advocacy Committee is responsible for an event during finals
17 week that provides testing materials for the students while simultaneously showing
18 Student Government's support of the student body of the University of North
19 Florida.

- 22 **Chapter 1201: SAC Chairperson**

- 24 1201.1 The SG Senate shall elect an SG Senator as Chairperson of the SAC ~~each~~
25 ~~spring and fall for one semester~~ in spring for a one-year term.

- 27 1201.2 The SAC Chairperson shall follow duties outlined in Senate Policies and
28 Procedures.
- 29
- 30 1201.3 The SAC Chairperson shall hold all meetings according to Senate Policies and
31 Procedures.

- 33 1201. 4 The SAC Chairperson shall report to Senate every meeting.
- 34
- 35 1201.5 The Chair of the Student Advocacy Committee shall only vote in the event of
36 a tie.
