# SENATE LEGISLATION

### *SR-10F-2438 Osprey Lighthouse Program*

7 Whereas: The Student Government of the University of North Florida was  
8 established to represent student concerns in all University wide matters,  
9 and;

10 Whereas: The Student Senate is the legislative body of the University of North  
11 Florida's Student Government, given the responsibility of carrying out  
12 such legislative acts that are necessary and proper for the Student Body of  
13 the University of North Florida, and;

14 Whereas: It is the responsibility of the Student Senate to maintain communication  
15 with the student body and the Student Government President on matters  
16 of concern to students; and

17 Whereas: According to Article II Section 6.C: Simple Resolutions shall be the formal  
18 expression of the opinion of the Senate or the legislative vehicle used for  
19 the internal regulation of the senatorial policies and procedures; and

20 Whereas: According to Title IV Chapter 400.1.J: The Student Senate shall be  
21 responsible for the Senate Policies and Procedures. The Senate Policies  
22 and Procedures is a living document which can only be changed through  
23 a Standing Rule which the Student Body President has no authority, and:

24 Whereas: The Purpose of the Lighthouse Program is to allow every A&S Fee paying  
25 student at the University of North Florida, to voice any concern through  
26 the members of the Lighthouse Program and provide each senator with  
27 direct contact with the rest of his/her constituency in order to better  
28 portray the voice of each student.

29 Whereas: According to Title IV Chapter 402.1.D: Each Session of the Student Senate  
30 shall adopt its own Rules and Procedures in accordance with the Student  
31 Government Constitution and Statutes, and;

32 Whereas: The Senate Policies and Procedures are in need of revision,
