- 9 Whereas: This purchase or activity reflects the genuine students interest and enhances the social,
10 cultural, and recreational interests of the University of North Florida students and;
- 11 Whereas: Student Government Legislative, in order to further enhance the social, cultural, and
12 recreational interests of the students of the University of North Florida, is seeking funding for
13 T-Shirts for the Osprey Lighthouse Program.
