SENATE LEGISLATION

SB-10F-2454

1 *SB-10F-2454 Student Council for Exceptional Children (SCEC)*

2 Whereas: The Student Government of the University of North Florida was established to represent
3 student concerns in all University wide matters, and;

4 Whereas: The Budget and Allocations Committee is a standing committee of the Student Government
5 Senate, responsible for funding only those entities that comply with the Student Government
6 mission which is to represent student concerns in all university wide matters while
7 developing and promoting programs and activities of practical value and interest to students,
8 and;

9 Whereas: This purchase or activity reflects the genuine students interest and enhances the educational,
10 social, cultural, and recreational interests of the University of North Florida students and;

11 Whereas: The students of the Student Council for Exceptional Children, are Activity and Service fee
12 paying students looking to enhance the cultural and social interests of the students of the
13 University of North Florida, and;

14 Whereas: The Student Council for Exceptional Children, in order to further enhance the cultural and
15 social interests of the students of the University of North Florida, are seeking funding for
16 travel to the Annual FCEC State Conference in Clearwater, Florida from October 21st, 2010 –
17 October 24th, 2010.

18 Whereas: The Student Council for Exceptional Children are requesting funding for the below items:

19	Registration: 6 students	X	\$40 per student	= \$240.00
20	Lodging: 2 room	X	\$135 X 3 nights / 50%	= \$405.00
21	Fuel: 2 vehicles	X	\$2.70/Mile X 31 Miles	= \$167.40

23	Total:			= \$812.40

25 Therefore: Let it be enacted, by the University of North Florida Student
26 Government, that \$813 be expended from the Student Conference Travel Index
27 402028 to pay for the above referenced items.
