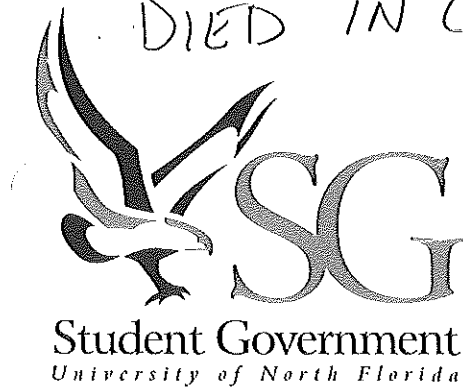

# SENATE LEGISLATION

## JR-10F-2460

### JR-10F-2460 : Yellow Ribbon Program

- 2 Whereas: The Student Government of the University of North Florida was established to  
3 represent student concerns in all University wide matters, and;
- 4 Whereas: In representing student concerns, Student Government as a whole believes that  
5 this concern should be addressed; and
- 6 Whereas: The Student Government Senate recognizes the sacrifices and contributions made  
7 by members of the Armed Service and the potential for enrichment they provide  
8 to the Student Body, the local work force and the Nation. And
- 9 Whereas: The importance of the Yellow Ribbon Program shall be recognized by both the  
10 Student Government Body and this University in efforts to retain Veterans  
11 Students at this University; and
- 12 Whereas: The University of North Florida recognizes its requirement to propose new  
13 services and programs for the student body that shall be executed by the  
14 University, to advocate for student issues. And
- 15 Whereas: The Student Body Senate and the office of the Student Body President, as  
16 representatives of the student body, further request all measures are undertaken to  
17 guarantee the continuation of funding for the Yellow Ribbon Program and all  
18 avenues are explored in order to expand the program beyond the current limits.
- 19 Therefore: Formally requests for the Office of the President of the University of North Florida along with The  
20 Board of Trustees to formally and in writing recognize the economic impact of this State  
21 Legislation on the population of Student Veterans as well as the potential positive impact to this  
22 University (UNF), which shall recognize the Yellow Ribbon Program.
- 23 Furthermore: Let this resolution be forwarded to the Board of Trustees, President John Delaney, Vice President  
24 for Student and International Affairs, Dr. Mauricio Gonzalez, Associate Vice President for  
25 Student Affairs, and Mr. Everett Malcolm.
