SB-10F-2462

1 *SB-10F-2462 National Society of Collegiate Scholars*

2 Whereas: The Student Government of the University of North Florida was established to represent
3 student concerns in all University wide matters, and;

4 Whereas: The Budget and Allocations Committee is a standing committee of the Student Government
5 Senate, responsible for funding only those entities that comply with the Student Government
6 mission which is to represent student concerns in all university wide matters while
7 developing and promoting programs and activities of practical value and interest to students,
8 and;

9 Whereas: This purchase or activity reflects the genuine students interest and enhances the educational,
10 social, cultural, and recreational interests of the University of North Florida students and;

11 Whereas: The students of the National Society of Collegiate Scholars at UNF, are Activity and Service
12 fee paying students looking to enhance the cultural and social interests of the students of the
University of North Florida, and;

14 Whereas: The National Society of Collegiate Scholars at UNF, in order to further enhance the cultural
15 and social interests of the students of the University of North Florida, are seeking funding for
16 travel to the NSCS Convention 2010/ Leadership Summit in Puerto Rico from June 15th,
17 2011 – June 19th, 2011.

18 Whereas: The National Society of Collegiate Scholars at UNF, is requesting funding for the below
19 items:

20 Registration: 4 students X \$495.00 = \$1,980.00

22 **Total:** = \$1,980.00

24 **Therefore:** Let it be enacted, by the University of North Florida Student
25 Government, that \$1,980 be expended from the Student Conference Travel Index
