## SB-10F-2464

*SB-10F-2464: Student Union Lighting*

2 Whereas: The Student Government of the University of North Florida was established to represent  
3 student concerns in all University wide matters, and;

4 Whereas: The Budget & Allocations Committee is a standing committee of the Student Government  
5 Senate, responsible for funding only those entities that comply with the Student Government  
6 mission, which is to represent student concerns in all university wide matters while  
7 developing and promoting programs and activities of practical value and interest to students,  
8 and;

9 Whereas: This purchase or activity reflects the genuine students interest and enhances the social,  
10 cultural, and recreational interests of the University of North Florida students and;

11 Whereas: The Student Union, in order to further enhance the social, cultural, and recreational interests  
12 of the students of the University of North Florida, is seeking funding for lighting just outside  
13 the 3800 rooms,

14 Whereas: The Student Union is requesting funding for the below items:

15	Lighting purchase & installation	X	\$12,828.00	= \$12,828.00
16	Permits and Contingency costs	X	\$1,282.80	= \$1,282.80

21 that \$14,111 be transferred from the Student Government Fund Balance to  
22 Special Projects index 402081 to be used to pay for the above items.
