9 10	Whereas:	This purchase or activity reflects the genuine students interest and enhances the social, cultural, and recreational interests of the University of North Florida students and;		
11 12 13	Whereas:	The Student Union, in order to further enhance the social, cultural, and recreational interests of the students of the University of North Florida, is seeking funding for lighting just outside the 3800 rooms,		
14	Whereas:	The Student Union is requesting funding for the below items:		
15 16 17		Lighting purchase & installationX $\$12,828.00$ $=\$12,828.00$ Permits and Contingency costsX $\$1,282.80$ $=\$1,282.80$		
18 19		Total: = \$14,110.80		
20 21 22	Therefore:	Let it be enacted, by the University of North Florida Student Government, that \$14,111 be transferred from the Student Government Fund Balance to Special Projects index 402081 to be used to pay for the above items.
