# SENATE LEGISLATION

## SB-10F-2470

1 *SB-10F-2470: Jacksonville Christian Life*

2 Whereas: The Student Government of the University of North Florida was established to represent  
3 student concerns in all University wide matters, and;

4 Whereas: The Budget and Allocations Committee is a standing committee of the Student Government  
5 Senate, responsible for funding only those entities that comply with the Student Government  
6 mission which is to represent student concerns in all university wide matters while  
7 developing and promoting programs and activities of practical value and interest to students,  
8 and;

9 Whereas: This purchase or activity reflects the genuine students interest and enhances the educational,  
10 social, cultural, and recreational interests of the University of North Florida students and;

11 Whereas: The Club, Jacksonville Christian Life is looking to enhance the cultural and social interests  
12 of the students of the University of North Florida, and;

13 Whereas: The Jacksonville Christian Life, in order to further enhance the cultural and social interests of  
14 the students of the University of North Florida, is seeking funding for travel to the Faith  
15 walkers 2010 at Ridgecrest, North Carolina from December 27 to December 31;

16 Whereas: The Jacksonville Christian life is requesting funding for the below items:

17	Lodging:	2 Rooms	X 4 Nights	X	\$90.00 per night	= \$720.00
18	Vehicle Rental:	3 Cars	X \$183.75 each			= \$551.25
19	Fuel:	3 Cars	X 60.13 miles per car	X \$2.75 per Gallon		= \$496.07
20	Registration:	16 Students	X \$30 each			= \$480.00

23 **Total:** = \$2,247.32

25 **Therefore:** Let it be enacted, by the University of North Florida Student  
26 Government, that \$2,248 be expended from the Student Conference Travel Index  
27 402028 to pay for the above referenced items.
