SB-10F-2471 : Women in Business

2 Whereas: The Student Government of the University of North Florida was established to represent
3 student concerns in all University wide matters, and;

4 Whereas: The Budget and Allocations Committee is a standing committee of the Student Government
5 Senate, responsible for funding only those entities that comply with the Student Government
6 mission which is to represent student concerns in all university wide matters while
7 developing and promoting programs and activities of practical value and interest to students,
8 and;

9 Whereas: This purchase or activity reflects the genuine students interest and enhances the educational,
10 social, cultural, and recreational interests of the University of North Florida students and;

11 Whereas: The Club, Women in Business is looking to enhance the cultural and social interests of the
12 students of the University of North Florida, and;

13 Whereas: The Women in Business Club, in order to further enhance the cultural and social interests of
14 the students of the University of North Florida, is seeking funding for travel to the Columbia
15 University Women in Business Panel in New York, NY From February 18th 2010 to
16 February 20th 2010;

17 Whereas: The Women in Business Club is requesting funding for the below items:

18	Airfare:	5 Students	X	\$209.98 each	= \$1,049.90
19	Lodging:	2 Room X 2 nights	X	\$323.65/night	= \$1,294.60
20	Registration:	5 Students	X	\$10 each	= \$50
21	Transportation:	1 Car	X	\$105.49	= \$105.49
