SB-10F-2476

1 *SB-10F-2476: Exercise Science Student Association*

2 Whereas: The Student Government of the University of North Florida was established to represent
3 student concerns in all University wide matters, and;

4 Whereas: The Budget and Allocations Committee is a standing committee of the Student Government
5 Senate, responsible for funding only those entities that comply with the Student Government
6 mission which is to represent student concerns in all university wide matters while
7 developing and promoting programs and activities of practical value and interest to students,
8 and;

9 Whereas: This purchase or activity reflects the genuine students interest and enhances the educational,
10 social, cultural, and recreational interests of the University of North Florida students and;

11 Whereas: The Club, ESSA is looking to enhance the cultural and social interests of the students of the
12 University of North Florida, and;

13 Whereas: ESSA, in order to further enhance the cultural and social interests of the students of the
14 University of North Florida, is seeking funding for travel to the 2011 ACSM Conference in
15 Greenville, South Carolina from February 3, 2011 to February 5, 2011;

16 Whereas: BSSA is requesting funding for the below items:

17	Lodging:	2 Rooms X 3 Nights	X	\$129 per room	= \$774.00
18	Transportation:	1 Vehicle	X	\$129.10	= \$129.10
19	Transportation:	1 Car X 51.73mpv X \$2.80 per gallon			= \$144.84

21 **Total:** = \$1,047.94

23 **Therefore:** Let it be enacted, by the University of North Florida Student
24 Government, that \$1,048 be expended from the Student Conference Travel Index
