# SENATE LEGISLATION

## SB-10F-2478

1 *SB-10F-2478: Student Physical Therapy Association*

2 Whereas: The Student Government of the University of North Florida was established to represent  
3 student concerns in all University wide matters, and;

4 Whereas: The Budget and Allocations Committee is a standing committee of the Student Government  
5 Senate, responsible for funding only those entities that comply with the Student Government  
6 mission which is to represent student concerns in all university wide matters while  
7 developing and promoting programs and activities of practical value and interest to students,  
8 and;

9 Whereas: This purchase or activity reflects the genuine students interest and enhances the educational,  
10 social, cultural, and recreational interests of the University of North Florida students and;

11 Whereas: The Club, Student Physical Therapy Association is looking to enhance the cultural and social  
12 interests of the students of the University of North Florida, and;

13 Whereas: The Student Physical Therapy Association, in order to further enhance the cultural and social  
14 interests of the students of the University of North Florida, is seeking funding for travel to  
15 the American Physical Therapy Association Combined Sections Meeting at the Ernest N.  
16 Morial Convention Center, New Orleans, Louisiana from February 9<sup>th</sup> to February 12<sup>th</sup>,  
17 2011;

18 Whereas: The Student Physical Therapy Association is requesting funding for the below items:

19	Registration:	15 Students	X	\$60 each	= \$900.00
20	Lodging:	4 Rooms X 3 Nights	X	\$75 per room	= \$900.00
21	Transportation:	4 Vehicles X 70 mpv	X	\$2.50 per gallon	= \$700.00
