# SENATE LEGISLATION

## SB-11S-2479

1 **SB-11S-2479: Appointment Review**

2 Whereas: The Student Government of the University of North Florida was established to represent student  
3 concerns in all University wide matters; and

4 Whereas: The Student Senate is the legislative body of the University of North Florida's Student Government  
5 given the responsibility of carrying out such legislative acts that are necessary and proper for the  
6 Student Body of the University of North Florida; and

7 Whereas: Legislation dealing with necessary and proper statutory revisions shall be considered by Student  
8 Senate;

9 Whereas: Title IV is in need of revision. The Student Government Signature page exists so that students can  
10 prove the attendance of Senate and Committee meetings and is due at the E&A Committee meeting.  
11 Currently, the E&A Committee is held before other committees, therefore appointees are not able to  
12 complete the signature page prior to E&A committee.

Therefore; The following revisions will be made to Title IV;

14 **TITLE IV: THE LEGISLATIVE BRANCH**

15 **Chapter 409: Appointment to Senate**

16 **409.2 Apply for Appointment/ Appointment Process**

17 Completed applications consist of:

19 B. Appointee Questionnaire, which discloses motivation to be a senator, goals if appointed, Student  
20 Government Signature Page, and other relevant information, at stipulated by the E&A Chair.

22 G. Attend an E&A meeting prior to the next scheduled Senate meeting for a Question & Answer  
23 Session. ~~At this meeting, the Student Government Signature page will be submitted.~~ Upon approval  
24 by a 2/3 vote, the appointee is forwarded to Senate for confirmation.

26 H. Submit a completed, time-stamped Student Government Signature Page by 5:00 pm the first  
27 business day following committee meetings. Failure to do so will result in a termination of the  
28 appointee's application.

32 **Furthermore: Let it be enacted, by the University of North Florida Student Government that the**  
33 **proposed revisions to Title VI be made effective July 1<sup>st</sup> 2011.**
