The current Election Timeline in Title VI is flawed, giving two (2) different dates for unqualified candidates to petition to the Student Judiciary. Additionally, the constitution gives only one (1) date for unqualified candidates to petition; therefore the Election Timeline is in noncompliance with 603.3 of Title VI.
