12 of North Florida, and;
- 13 Whereas: ASCE, in order to further enhance the cultural and social interests of the students of the
14 University of North Florida, is seeking funding for travel to the 2010 Southeast Regional
15 Conference in the Tennessee Technological University in Cookeville, TN from March 24th,
16 2011 to March 27th, 2011;
