7 developing and promoting programs and activities of practical value and interest to students,

- 9 Whereas: This purchase or activity reflects the genuine students interest and enhances the educational,
10 social, cultural, and recreational interests of the University of North Florida students and;
- 11 Whereas: The Wrestling Club is looking to enhance the cultural and social interests of the students of
12 the University of North Florida, and;
- 13 Whereas: The Wrestling Club, in order to further enhance the cultural and social interests of the
14 students of the University of North Florida, is seeking funding for travel to the NCWA
15 National at the Nationals-Mercer University from March 13th, 2011 to March 13th, 2011;
- 16 Whereas: The Wrestling Club is requesting funding for the below items:
